Right to data portability (art. 20)	You have the right to receive in a structured format, commonly used and machine-readable, the personal data that you provide us with and you have the right to transmit them to another Controller if the processing: (i) was based on consent, (ii) was based on contract and (iii) and if the processing is carried out by automated means, unless the processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority and such transmission does not infringe the rights of a third party. Right to object (art. 21)	You have the right at any time to object, in whole or in part, to the processing of your personal data if the processing is carried out for the pursuit of a legitimate interest of the Controller or if the processing is carried out for direct marketing purposes. In this case, the personal data will no longer be processed for these purposes.	Forms on the website or available from the Controller
Right to lodge a complaint with a supervisory authority (art. 77)	You have the right to complain to the Control Authority if you consider that the processing of your data is in breach of the GDPR	

The exercise of these rights is subject to the limits, rules and procedures laid down by the GDPR. The data subject must know them and implement them. Furthermore, in accordance with the provisions of article 12, paragraph 3, the Controller shall provide the data subject with information relating to the action taken without undue delay and, in any event, no later than one month after receipt of the request. This period may be extended by two further months, if necessary, taking into account the complexity and number of the requests. The Controller shall inform the data subject of such extension, and of the reasons for the delay, within one month of receipt of the request.

#### Changes and updates

This information may be subject to change and/or addition, including as a result of the applicability of the GDPR and any future changes and/or regulatory updates.

The updated information is constantly available on the website of the Controller.

The personal data provided may be processed by the Data Controller with or without by computer tools.
